I LOVE Wallum

Day 5 of Civil Disobedience - V Day 2024

I LOVE Wallum. V Day, 14th February 2024, marks the fifth day of nonviolent direct action (NVDA) at the 30 ha property on the banks of the Simpsons Creek, in the iconic Byron Shire.

A peaceful community presence is now in full activation next to the Wallum site, which is under imminent threat of being cleared by bulldozers. The site contains many old-growth, or pre-colonial, Scribbly Gums with large hollows which are vital habitats and culturally important but the trees are earmarked for destruction.

Dozens of people are expressing their love of Country by holding vigil at Wallum to ensure this ecologically significant and vulnerable landscape is defended.

Save Wallum has a Welcome Tent, Tea Tent, Basecamp and various creative non-violent direct action (NVDA) installations on site. One of these installations is a tree sit, perched high in the branches of another Scribbly Gums earmarked for destruction by investment company, Clarence Property.

Alyssa, the young eco-warrior sleeping in the tree sit tonight, is positioned high up in a giant old **Scribbly Gum** on the proposed development site and vows to stay there until Wallum is saved. "*I will stay here as long as it takes to Save Wallum. This is such an important and precious area and we must protect it and stop destroying these rare and culturally significant coastal areas. There is less than 1% of this coastal heathland left in this shire. We have to do something now*", she said.

The situation became critical on Thursday 8th February when Byron Shire Council decided to accept the revised reports for the Wallum development and allow their staff to issue the subdivision certificate for works to start. The vote was tied and Mayor Michael Lyon used his casting vote to allow the certificate to be issued.

Spokesperson for Save Wallum, Svea Pitman, said "The revised reports are seriously erroneous and the effect on the environment would be catastrophic if this subdivision proceeds. We implore Minister Plibersek to refer this matter herself, immediately for assessment under the national environemental laws - the EPBC Act, today."

"The community is now left with no choice but to defend this place with our bodies on the front line," she continued.

Come and join us at Wallum - on Thursday the 15th February, we are hosting a full day of activites, with the Knitting Nannas on site, various workshops on aspects of getting involved and performance by the Biggest Little Town Choir. Flyer attached.
